# Circular to NCWCCL Clubs 25<sup>th</sup> March 2022

### **Spring Meeting / Captains Meeting**

The WCCL Spring Meeting will be on Monday 25<sup>th</sup> April 2022, at Beversbrook Calne. The meeting will start at 7:45pm.

Unfortunately the 2021 season saw an increase in both the number and the severity of disciplinary incidents. Therefore the Spring Meeting will double up as a captains meeting to discuss the responsibility which captains have. All clubs must attend, and ideally, should send the captain of their highest WCCL team. If this person cannot attend, then it must be the captain of another team, or a senior player – someone who is able to relay the league's message back to all players at the club.

As well as receiving match balls, score books, etc, this year clubs will also be receiving a cricket first aid kit for each ground. Thanks go to Neon Cricket who are providing these as part of their sponsorship of the league.

#### **League Rules**

The league rules for the 2022 season are now available to download on the league website. Please make sure all team captains are conversant with the league rules. At the front of the rules are a list of the rules which have changed for the 2022 season, which all captains need to read and relay to their players.

#### **Teas**

Thank you to all those clubs who have provided information about whether they will be providing teas on the website. A few still need to so:
